
- i) Distance of nearest petrol pump on both side of the proposed location.
- ii) Distance from Toll barrier/state boundary.
- iii) GPS coordinates of proposed site.
- iv) For a small diverted forest area of 114 Sq.m., felling of 28 trees is very high. DFO/CF to reinspect and reduce number of trees to be felled, if required, realign inlet/ outlet.
- iv)a) The State Government shall complete settlement of rights, in terms of the Scheduled Tribes and Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, if any, on the forest land to be diverted and submit the documentary evidence as prescribed by this Ministry in it's letter No. 11-9/1998-FC (pt) dated 3rd August 2009 read with letter No. 11-9/98-FC(pt.) dated 5th February 2013, in support thereof & submit certificate in prescribed format

or

- b) As prescribed by this Ministry in its letter No. 11-09/98-FC (pt), dated 28th October, 2014, in case of plantations which were notified as 'forest', a certificate from the concerned District collector to the effect that the forest land proposed to be diverted is plantation which was notified as "forest' less than 75 years prior to the 13th day of December 2005 and is located in villages having no recorded population of Scheduled Tribes as per the census-2001 and the census 2011, be issued and submitted to meet requirements of clause (a), read with clause (d) and clause (g) in second para of this ministry's letter issued vide F.No. 11-9/1998-FC(pt), dated 3rd August. 2009.
